1. To ensure implementation of reservation of 5% of seats in the University in terms of Section 32 of the Rights of Persons with Disabilities Act, 2016;
2. To formulate mechanism for orientation and sensitization at University level regarding rights of persons with Disabilities (PWDs) in terms of Section 39(2)(d); and to ensure that the rights of PWDs are included in the curriculum in University in terms of Section 39(2)(f);
3. To ensure providing inclusive education to children/students with disabilities in terms of the provisions of Chapter III of the PWD Act, 2016;
4. To ensure implementation of other provisions of the Rights of Persons with Disabilities Act, 2016.
