- To formulate mechanism for orientation and sensitization at University level regarding rights of persons with Disabilities (PWDs) in terms of Section 39(2)(d); and to ensure that the rights of PWDs are included in the curriculum in University in terms of Section 39(2)9(f);
- 3. To ensure providing inclusive education to children/students with disabilities in terms of the provisions of Chapter III of the PWD Act, 2016;
- 4. To ensure implementation of other provisions of the Rights of Persons with Disabilities Act, 2016.
