
**Sub: Conducting of final semester examinations for the outgoing students –

In light of references cited at '5' and '6' above and the Heads & Deans committee meeting held on 01-09-2020, the following are brought to the notice of all concerned. This is in supersession of all communications made in this regard earlier.

1. All results declared earlier for final semester/terminal semester (January-June 2020 semester) are cancelled with immediate effect.
2. The University will conduct the end semester special examinations for the Integrated, PG and M.Tech final semester students from 16 to 22 September, 20 in first phase. Those who cannot write the exam in the first phase can write in second phase from 5-12 October, 2020. This exam will be for 50 marks. The syllabus would be the course taught upto 13-3-20 i.e. before lockdown.
3. For the practical/laboratory/dissertation and project courses, the final marks will be assessed out of 100 marks.
4. The outgoing students will not be allowed to come to the campus for writing the end semester exams. The mode of examination online/offline may be decided by the Academic Unit. However, the Deans of School/Heads of Departments/Centres have to inform the Controller of Examinations about the mode of examination used for their students in all courses at least five days before the exams.

5. For the outgoing students who may not have appeared for any continuous assessment, or opted for zero marks, the faculty/Academic Unit may conduct the exam in any mode as deemed appropriate and update the marks scaled to 25 marks. Those who have already appeared for the continuous assessment cannot write the exam again.
