

# UNIVERSITY OF HYDERABAD ADMISSIONS 2016-17

## INSTRUCTIONS TO THE CANDIDATES CALLED FOR COUNSELLING/ADMISSION TO VARIOUS COURSES DURING THE ACADEMIC YEAR 2016-17

- 1. The candidates should report <u>IN PERSON</u> to the Joint Registrar (Academic & Exams) on the date, time and the place specified in the Notification. **No Proxy** will be permitted to attend the counselling and complete the admission formalities if granted.
- 2. On verification of the certificates and other related documents, if the admission is offered, the candidates should complete the admission formalities on the same day. Normally, no extension of time will be permitted for any reason/s. Therefore, the candidates are advised to obtain the signature of their parent/guardian in the online application form and in the undertaking and keep them ready for submission at the time of admission.
- 3. At the time of admission, the candidates should submit the following documents in original along with a set of self-attested copies for verification. Except the Transfer Certificate, all other original certificates shall be returned to the candidate after verification. Candidates who do not submit the qualifying degree certificate shall be **granted conditional admission only**.
  - a. CAT/GATE/IIT-JEE Mains and Advanced 2016 score card (Wherever applicable).
  - b. Mark sheets from Matriculation onwards.
  - c. Pass Certificate of the qualifying examination.
  - d. Transfer Certificate / Migration Certificate.
  - e. Latest Caste Certificate issued by the competent authority (in case of OBC) certificate issued on or after 1.4.2015 by the Competent Authority in Govt. of India (GOI) format.
  - f. Medical Certificate issued by a Civil Surgeon of a Govt. Hospital (in case of candidates with Disabilities only).
  - g. Certificate from a Competent Authority of the Defence Department in case of Wards/dependents of Defence personnel (DP).
  - h. Certificate of Competent Authority in case of candidates selected under Migrants of Jammu & Kashmir quota.
  - i. The candidates who have been conditionally called for admission on the basis of their claim of JRF qualification / information on the appearance in the NET for JRF must produce at the time of admission, **AWARD LETTER** of their UGC/CSIR NET for JRF, NBHM/ICMR/DBT JRF/ DST INSPIRE FELLOWSHIP/RGNF/MANF without which they will not be permitted to complete the admission. Therefore, the candidates those who could not produce the **AWARD LETTER** will not be granted admission though their names are figured in the admission notification.

**Note:** The original T.C./M.C. shall be retained by the University permanently which shall not be returned to the candidates.

- 4. The candidates have to fill the following forms (enclosed) and submit the same at the time of admission:
  a) Check list (Annexure I)
  - b) Anti-Ragging Form (Annexure II)
  - c) Medical Declaration Form. (Annexure III)
  - d) Undertaking by the candidate with counter signature of his/her parent/guardian in the prescribed form. (Annexure IV)
  - e) Two photographs: One photograph should be pasted on online application form and the other on Medical Declaration Form.
  - f) Application form for Admission Withdrawal (Annexure V) If required.
- 5. After verification of all the certificates and if the candidates are found eligible for admission in all respects, then only they will be permitted to proceed for admission (as given in the admission notification) Demand Draft in favour of Finance Officer, University of Hyderabad, payable at Hyderabad/Online payment through SBI I-Collect.
- 6. OBC (non-creamy layer) Candidates should submit the certificate in the prescribed format (obtained on or after 1.4.2015) in support of their claim issued by a Competent Authority without which they will not be permitted to complete the admissions and the provisional selection for admission under OBC category stands automatically cancelled.

- 7. (a) Candidates should submit the result of the qualifying examination and other earlier examinations positively at the time of admission. In exceptional cases, extension of time is given upto 30.7.2016. Such candidates will be given conditional admission upto 30.7.2016. If they fail to submit their result by 30.7.2016 and fail to pass the qualifying Degree examination with the prescribed percentage of Marks etc., they would not be allowed to attend the classes any further and their conditional admission would be cancelled forthwith. However, this extension in exceptional cases till 30.7.2016 is not allowed in the case of candidates taking regular or supplementary or improvement examinations of the qualifying degree after 30.7.2016 and waiting for the results.
  - b) In the case of non-submission of other certificates like TC/MC etc. other than the qualifying exam certificates, candidates may be allowed time upto 30.7.2016 to submit the same failing which such admissions will also be cancelled without any notice.
  - c) Candidates seeking admission for Ph.D. Programme on the basis of M.Phil degree must provide a certificate from Department/School/University concerned, that they have submitted the M.Phil Dissertation by 30-6-2016, failing which they will not be granted admission.
  - d) The candidates who have been conditionally called for admission on the basis of their claim of JRF qualification / information on the appearance in the NET for JRF must produce at the time of admission, AWARD LETTER of their UGC/CSIR NET for JRF, NBHM/ICMR/DBT JRF/ DST INSPIRE FELLOWSHIP/RGNF/MANF without which they will not be permitted to complete the admission. Therefore, the candidates those who could not produce the AWARD LETTER will not be granted admission though their names are figured in the admission notification.
- 8. No relaxation in the minimum percentage of marks prescribed for admission will be made under any circumstances except in the case of candidates belonging to SC/ST and physically challenged.
- 9. Further, candidates of SC/ST categories who <u>leave the course prior to the sanction of the Scholarship</u> by the Social Welfare Department, Govt. of Andhra Pradesh/Telangana should pay the full fees and clear all their dues, failing which they will not be given Transfer cum Migration Certificate.

The SC/ST students belonging to state of Andhra Pradesh/Telangana who have availed fee concession shall have to pay full amount of fee in case withdrawing the admission before the scholarship is sanctioned by the Social Welfare Dept. of Govt. of Andhra Pradesh/Telangana.

- 10. The tuition and other fees shall be adjusted after receiving their scholarship amount from the Social Welfare Department, Govt. of Andhra Pradesh/Telangana Such candidates who want to avail this facility, should submit the latest income certificate issued by a competent authority for the year 2015-16 (1.4.2015 to 31.3.2016) and a certificate from the Principal / Head of the Institution last studied that the candidate was in receipt of GOI Post-Matric Scholarship. However, if the Social Welfare Department does not sanction the scholarship and fees on any grounds, the student is responsible for clearing all the dues.
- 11. Candidates admitted in a course are not allowed to pursue any other course or take up any job during the period of their study. Those employed, if selected have to obtain necessary leave, for the duration of the course and furnish a copy of the leave order, relieving order, conduct certificate and 'NO OBJECTION CERTIFICATE' from their employers at the time of admission.
- 12. Candidates medically unfit shall not be admitted.
- 13. 75% attendance in each course is compulsory. Participation in seminars, Sessionals and practicals as prescribed to the satisfaction of the School is a must, failing which they shall not be allowed to appear in the semester-end examinations. The names of students shall be removed from the rolls of the University if they abstain from classes continuously for more than 10 days.
- 14. No student can claim the Hostel seat as a matter of right. The Hostel accommodation is limited and is not assured. The hostel accommodation is provided subject to availability based on the distance from their present place of residence with sufficient proof on first come first serve basis. Students belonging to SC/ST/OBC categories should produce their Caste Certificate at the time of Hostel admission. The accommodation is provided for the duration of the course. No hostel accommodation shall be provided to the students from the places within the limits of Greater Hyderabad Municipal Corporation (GHMC).
- 15. The students should bear the expenses related to visits/educational tours etc., if arranged and considered essential for the programme.
- 16. The students should register in the beginning of each semester, by applying for the same in the prescribed form (available in the Office of the School/Dept./Centre).

#### 17. Refund of deposits and fees:

The rules for refund of fee to students on account of withdrawal/cancellation of admission etc. approved by the University in 75<sup>th</sup> Academic Council meeting (item No.AC:75:2K15:24 and 167<sup>th</sup> EC), for implementation w.e.f. the academic session 2015-2016, are given below for compliance by all concerned:

- **18.** Such of the wait-listed candidates who desire to be considered for admission against the vacant seats, if any, should report in person at the prescribed time and date at the place specified in the respective Notification giving the names of wait-listed candidates. In case the admission is granted, the candidates have to complete the admission formalities on the same day. No extension of time will be permitted for any reason/s. Therefore, such candidates are advised to obtain the signature of their parent/guardian on the undertaking form (**Annexure–IV**) and keep ready with them for submission at the time of admission, if granted. The vacancy position in respect of the courses shall be displayed on the date of operation of the waiting list for that course.
- **19.** After completing the admission formalities, the students should collect their Admit Slip at the Admission Office and submit the same in respective School/Department/Centre.
