All the on-rolls M.Phil. and PhD scholars are informed to complete their semester registration for the Monsoon Semester (July-December 2020) through the e-governance portal. It is further informed that due to the extenuating circumstances of the COVID–19 pandemic, all the PhD students who are coming up for either extension from 5<sup>th</sup> to 6<sup>th</sup> year, or de-registration after the 6<sup>th</sup> year as on 30-06-2020 are given an additional 6 months time i.e. up to 31.12.2020. Likewise all the M.Phil. Students who have completed 2 years in June 2020 will be given time of 6 months i.e. up to 31.12.2020 for submission of dissertation.

The following procedure may be followed for the Semester Registration by all the M.Phil. and PhD students on rolls (except those mentioned above):

- 1. Upload DRC report (or) Declaration by supervisor stating, "The student has been in regular contact with me and I have been monitoring his/her work during this period".
- 2. To clear hostel dues, if any.
- 3. Undertaking to pay the semester fee given in website: <a href="http://acad.uohyd.ac.in/download.html">http://acad.uohyd.ac.in/download.html</a> (semester wise fee) for the semester July-December 2020, during next semester registration or along with no dues certificate. This is a special one-time permission being given due to prevailing circumstances.
- 4. The last date of semester registration is 10.08.2020
- 5. Because of the continuing rise in cases of Covid-19 in Hyderabad and elsewhere in the country, despite the registration, all research scholars are advised to continue to work from their respective locations and remain in regular contact with their Supervisors. They are not to return to the campus until further notice. Those research scholars in the Science Schools with essential experimental work to complete in the labs are requested to await specific instructions from their respective Supervisors and Department Heads/Deans.
