PROVISIONAL ORDER

Sub: Delayed PhD Submission and Retrospective De-registration

The committee constituted by the 81st Academic Council to review the representations of the PhD Scholars requesting Permission for Delayed Submission of PhD thesis and for retrospective de-registration, reviewed 68 representations as below.

No. of Cases where Scholars did not De-register in the stipulated time and are now allowed to de-register retrospectively.	30

As per the recommendations of the committee and further approval of the competent authority 66 Scholars are granted permission as below subject to the fulfillment of the conditions stated in this order.

A. Delayed PhD Submission: The scholars in **Annexure-A** are granted time till 30-09-2018 as a onetime measure to submit their thesis subject to the following conditions.

1. All Scholars granted permission for delayed submission of Thesis have to pay fee applicable mentioned against their names in the last column of Annexure A.

[Total fee applicable = ₹5000 (late submission fee) + ₹5000 for each delayed semester (No of semester that the scholar did not do semester registration)]

2. The students those who are ready to submit Thesis on or before 30-09-2018 should submit the following to the office of the Controller of Examinations **within 10 days** of issue of this order.
 - a. Undertaking as in **Annexure D** duly endorsed by the Supervisor, Head & Dean.
 - b. Proof of Payment of applicable fee (as in last column of Annexure A) via Challan/DD in favour of 'The Finance Officer', University of Hyderabad.
 - c. No Dues Certificate (Scholars those who have already submitted NDC earlier may submit a proof of the same)
3. Cases where the Supervisor has superannuated or will be superannuating, the scholar has to approach the Head of the Department/Centre/Dean of School to designate a regular faculty as "Supervisor" and superannuated faculty as "Co-supervisor", before recommendations are sent to Administration for further action, while enforcing UGC 2016 regulations.

B. Retrospective De-Registration: The scholars in **Annexure-B** are granted one time permission to do de-registration w.e.f the date applicable against their names subject to conditions below.

1. All Scholars granted permission for Retrospective De-Registration have to pay fee applicable mentioned against their names in the last column of Annexure B.

[Total fee applicable = ₹5000 (late submission fee) + ₹5000 for each delayed semester (No of semester that the scholar did not do semester registration)]

2. The students in Annexure B should apply for retrospective de-registration to the Office of Controller of Examinations **at the earliest but not later than 10 days** from the issue of this Order
 - a. De-registration application in the prescribed format.
 - b. No Dues Certificate.
 - c. Undertaking as in **Annexure E** duly endorsed by the Supervisor, Head & Dean
 - d. Proof of Payment of applicable fee (as in last column of Annexure B) via Challan/DD in favour of 'The Finance Officer', University of Hyderabad.
3. The Scholar will be deemed to have de-registered from the stipulated date and the period by which the student has defaulted will be reduced from total de-registration period of 5-years. **The remaining de-registration period will be called as residual period within which the student has to apply for re-registration following due process, for submission of the thesis.**
4. The Scholars whose de-registration have been formalized, will have to attend DRC every semester during remaining period of the residual de-registration period. The DRC reports and the recommendation have to be quantifiable (in terms of tangibles like, field work completed, papers published, chapters written and reviewed, work remaining etc.) The DRC has to ensure that thesis is close to final draft version and satisfies other

mandatory conditions, as applicable, at the time it recommends for re-registration and before expiry of the residual de-registration period.

5. Cases where the Supervisor has superannuated or will be superannuating, the scholar has to approach the Head of the Department/Centre/Dean of School to designate a regular faculty as "Supervisor" and superannuated faculty as "Co-supervisor", before recommendations are sent to Administration for further action, while enforcing UGC 2016 regulations.

C. Representation not Considered: Representation of the scholars in **Annexure-C** is are not accepted/reviewed due to reasons mentioned against their names.

Note: This order is issued as a onetime measure subject to fulfillment of the conditions mentioned. This order or part of it cannot be quoted as a precedence in future under any circumstance.




