- **Sub:-** Discontinuation of issuing Transfer Certificate/Migration Certificates at University of Hyderabad for the students admitted from the Academic Year 2025-26 onwards- Reg
- **Ref:-** 1. UGC letter D.O.No.F.1-46/2020(NAD/Digi locker) dated 3.1.2022 on acceptance of Degree, Mark-sheet and other educational documents presented through the Digi locker platform.

 - 5. Resolution Item No.AC:94:2024:11 of 94th Academic Council Meeting of the University of Hyderabad held on 22nd November 2024.

According to the Guidelines for Pursuing Two Academic Programmes simultaneously, issued by University Grants Commission vide references (1) to (4) read above, the Academic Council of the University of Hyderabad has resolved to implement the policy of Pursuing Two Academic Programmes simultaneously and consequently, to discontinue the issuance of Transfer Certificate/Migration Certificate.

Since the policy allows a student to pursue two full-time academic programmes simultaneously, the students now can take admission to another Higher Education Institution without leaving one Higher Education Institution. To facilitate this provision, the University of Hyderabad has discontinued the practice of issuing as well as collecting Transfer Certificates and Migration Certificates to/from its students, beginning with the students admitted from the Academic Year 2025-26 onwards.

It is the sole responsibility of the student to abide by the UGC Guidelines for Pursuing Two Academic Programmes simultaneously and the rules and regulations of the Higher Education Institution concerned where the student takes admission without hiding any facts.

In view of the above, all concerned are herewith requested to consider the cases of University of Hyderabad students without demanding Transfer Certificate and Migration Certificates for all purposes including higher/further education and jobs.

It is advised that the concerned may check and verify the genuineness of the marks sheets or degree certificate either through the National Academic Depository (NAD) or by sending the copies of documents of the students and get them verified as per the verification policy of University of Hyderabad available on its website acad.uohyd.ac.in.
