
In continuation to the decision of the 71<sup>st</sup> Academic Council meeting held on 19-09-2013 under Item No.AC:71:2K13:18 (copy enclosed) wherein it was resolved to prospectively grant exemption from payment of fee beyond the amount reimbursed by the Government of Telangana and Andhra Pradesh which was taken by the University considering the difficulties faced by the students due to the delay in sanctioning and release of amount for the SC/ST/OBC students belonging to the States of Telangana and Andhra Pradesh with parental income below Rs.2.00 lakhs.

In order to streamline the exemption of tuition fees to the Social Welfare Scholarship beneficiaries beyond the amount reimbursed by the Social Welfare Departments of the Govt. of Telangana and Andhra Pradesh, the following guidelines will come into effect immediately.

1. It is clarified that the Academic Council decision for waiver of differential amount of fee that is sanctioned by the State Governments of Telangana & Andhra Pradesh for SC/ST & OBC students, will continue till further orders.
2. The cases of those students in respect of whom the sanction orders have been received only shall be considered for waiver of difference of fee amount.

3. Mere submission of application shall not entitle a student for waiver of fee and total fees cannot be waived.
4. The facility of waiver of difference amount of fee over and above what has been sanctioned by the respective State Governments shall not be applicable for the candidates who take re-admission/re-course.
5. The candidates who have applied for sanction of Social Welfare Scholarship shall not be entitled for waiver of fee, in case no sanction order is received for respective year of study, such students will have to pay the entire applicable fee.
