NOTIFICATION

Sub: Conduct of Supplementary, Special Supplementary & Improvement Examinations, February, 2021- Reg.

Notification for conduct of Supplementary, Special Supplementary and Improvement examinations are scheduled to be conducted between **11.02.2021 to 14.02.2021**. The eligibility criteria and details pertaining to the examinations, fee payable and other details are given below:

A. SUPPLEMENTARY EXAMINATIONS:

The Students who have obtained "**F Grade**" in any of the courses and/ or who abstained from the Semester examinations held in December, 2020 and were otherwise eligible also can appear for the Supplementary examinations. **Students with shortage of attendance are not eligible to appear for Supplementary examinations.**

B. SPECIAL SUPPLEMENTARY EXAMINATIONS:

- The PG/Integrated PG students, who after completion of the prescribed duration of the course are left with backlogs are eligible to appear for special supplementary examinations subject to a maximum of two courses where the number of courses in a semester are four and a maximum of three courses where the number of courses in a semester are more than four. **Appearance in such examinations shall be allowed only once.**
- Students with shortage of attendance are not eligible to appear for Special Supplementary examinations.**
- Students those who are appearing for Supplementary Examinations during February 2021 are not eligible to appear for Special Supplementary Examination for the same paper during the above schedule.**
- The Students of M.Phil/M.Tech/Ph.D. courses are not eligible for Special Supplementary Examinations.

C. IMPROVEMENT EXAMINATIONS:

- This provision is open to all those students who wish to improve their grades irrespective of the SGPA/CGPA obtained by them. *However, the student should clear all the courses of a particular semester in which he/she intends to take improvement examination. Appearing for Improvement Examinations along with the Supplementary Examinations pertaining to the same subject or different subjects simultaneously in a particular Semester **shall not be** permitted.*

- ii. Students those who wish to improve their grades for the papers written in previous semesters are permitted to improve two courses at the end of second semester and three courses at the end of third semester and so on.
- iii. Students who had already appeared for Improvement examination in a particular course in the semester concerned is not eligible to appear for Improvement examination again in the same course of the Semester concerned. However, the student may appear for Improvement exam/s in other course/s in the same Semester up to the maximum number of Improvement exams **as per the clause C (ii) above.**
- iv. Students those who had completed the course and wish to improve any of the papers, can apply for the same within a maximum period of six months after completion of the course.


D. SUBMISSION OF APPLICATION:

- i. The students concerned should submit the prescribed application form in the Egov portal on or before **08th February, 2021**. The School/Dept./Centre concerned shall verify and forward the applications of only such students who are eligible as per this notification, to the Examinations Section by **10.02.2021 for records through E-governance.**
- ii. The concerned Schools/Depts./Centres have to strictly ensure the eligibility of the students while accepting and forwarding the applications for Supplementary, Special Supplementary and Improvement Examinations and allow the students to appear for the respective exams.

E. RESULTS:

The results of Supplementary, Special Supplementary & Improvement examinations may be uploaded by the Schools/Depts./Centres to the Office of the Controller of Examinations on or before **16.02.2021 in E-governance portal**
