2. Course work done with 12-14 credits
3. Evaluation of the Ph.D. thesis by at least two external examiners
4. Open Ph.D. viva voce of the candidate had been conducted
5. Candidate has published one research papers from his/her Ph.D. work out of which at least one must be in a refereed journal before submitting the thesis for adjudication
6. Pre - Submission cum open viva should be conducted before the submission of Ph.D. thesis.

For issue of UGC Regulation 2016 following conditions are to be met: (2017 Admission Onwards)

1. Ph.D. degree of the candidate should be awarded in regular mode only
2. Course work done with 12-14 credits
3. Evaluation of the Ph.D. thesis by at least two external examiners
4. Open Ph.D. viva voce of the candidate had been conducted
5. Candidate has published one research papers from his/her Ph.D. work out of which at least one must be in a refereed journal before submitting the thesis for adjudication
6. Candidate has made at least two presentations in conferences/ Seminars, based on his/her Ph.D. work.
7. Pre - Submission cum open viva should be conducted before the submission of Ph.D. thesis.

For M.Phil. Degree Holders

For issue of UGC Regulation 2009 following conditions are to be met: (Enrolled between 2009 & 2017)

1. M.Phil. degree of the candidate should be awarded in regular mode only
2. Course work done
3. Evaluation of the M.Phil. dissertation by at least one external examiner
4. Open M.Phil. viva voce of the candidate had been conducted
5. Pre - Submission viva should be conducted before the submission of M.Phil. dissertation.

For issue of UGC Regulation 2016 following conditions are to be met: (2017 Admission Onwards)

1. M.Phil. degree of the candidate should be awarded in regular mode only
2. Course work done not less than 24 credits
3. Evaluation of the M.Phil. dissertation by at least one external examiners
4. Open M.Phil. viva voce of the candidate had been conducted
5. Candidate has published research papers from his/her M.Phil. work out of which at least one must be in a refereed journal before submitting the dissertation for adjudication
6. Pre - Submission viva should be conducted before the submission of M.Phil. dissertation.

Note: For both M. Phil & Ph.D.

- a) **Candidates admitted prior to 11th July, 2009 are not eligible for getting 2009/2016 UGC Regulation certificate since they have not fulfilled the terms and conditions laid down by the UGC. They will be issued a certificate stating that “the Degree awarded is deemed to be in concordance with the Regulations of the UGC”.**
- b) **Interested candidate can apply for the same by paying a fee of Rs.100/- through payment gateway.**
- c) **All the students are requested to go through the above and the UGC Regulations 2009/2016 before applying for the certificate.**
