The 81st Academic Council resolved, the following procedure to be adopted to consider the delayed cases of PhD submissions in the University:

- 1. The Academic Council, constituted a committee consisting of DSW, Prof, Arun Agarwal, Dean, School of Computer and Information Sciences and Prof B. Rajasekhar, Dean, School of Management Studies to review the appeals of the students for delayed submission of the PhD thesis.
- 2. The relevant information will be issued to all Deans/ Heads of the Schools/ Departments/ Centres, to inform the Supervisor and the candidates in their respective Academic unit, about the procedure to apply. The last date and time for this submission is March 24, 2018 5.00 pm to the DSW Office. The prescribed form along with evidence, draft thesis will be submitted. They will also have to pay Rs 5000/- per semester for the delayed, semesters.
- 3. The student along with the Supervisor should present his/her case before the committee with justification of being able to submit the thesis. The committee will interact with the student and the Supervisor **between 26 to 28, March, 2018**, and recommend on a case-by-case basis for allowing time **till 30-9-2018** or recommend for De registration in accordance with the relevant rules.
- 4. In absence of supervisor (due to superannuation, long leave etc), the Head/ Dean shall make necessary arrangements for a faculty to act as supervisor in that case.
- 5. The orders for such candidates shall be issued after taking VC's approval.
- 6. The Academic Council, also resolved to strictly follow the schedule mentioned above and it is last and final opportunity being given to the students and there will not be any further relaxation for any reasons.
